TRADE-MARK ASSIGNMENT

WHEREAS, Assignee is desirous of acquiring all of Assignor's right, title and interest in and to the Trademark Applications and Registrations, the Marks and that portion of the business that pertains to the Marks for all countries of the world other than the European Community, including the United Kingdom, and South Africa;

NOW, THEREFORE, for \$1.00 (One Canadian dollar) and other good and valuable consideration, the sufficiency of which is hereby acknowledged, it is hereby agreed as follows:


1. Assignor does hereby sell, assign, transfer, convey and set over to Assignee, its successors and assigns, all of its right, title and interest in and to the Trademark Applications and Registrations, the Marks and that portion of the business that pertains to the Marks, together with the good will of the business symbolized by the Marks, including, but not limited to, the right to petition, sue or otherwise seek and recover damages, profits or any other remedy (monetary, injunctive, declaratory or other), for any past, present or future infringement, dilution, conversion or misappropriation of, or other injury, offense, violation, breach of duty or wrong relating to the Marks, or any license, agreement, contract or other matter relating thereto.

2. Assignor agrees that it will execute and deliver, or cause to be executed and delivered, to Assignee or Assignee's legal representatives, any other or additional assignments,

powers or other appropriate documentation, and take all additional actions, necessary to effectuate, validate and record the assignment of the Trademark Applications and Registrations to Assignee with the appropriate agencies and offices of all jurisdictions in which the Marks are or may be registered or in which applications for registration of the Marks are pending, other than the European Community, including the United Kingdom, and South Africa, within a reasonable time of execution hereof. Assignor also agrees to execute such additional documents as Assignee deems reasonably necessary to establish Assignee's rights in the Marks, including, but not limited to, such documents to establish the dates of first use for the Marks covered by the Trademark Applications and Registrations, anywhere and in commerce, by Assignee through Assignor.



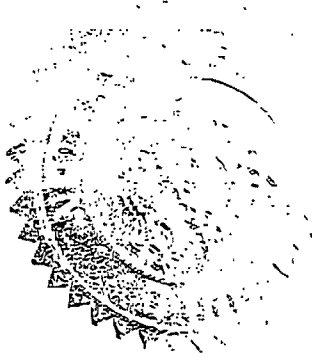
