ASSIGNMENT OF TRADEMARKS

ASSIGNMENT

This Agreement is effective the 29th day of March 2006 between The Bugatti, Inc., a Massachusetts corporation with an address at 100 Condor Street, Boston, Massachusetts 02128 ("ASSIGNOR"), and Bugatti International S.A., a Luxembourg corporation with a business address of 8-10, Rue Mathias Hardt L-1717, Luxembourg ("ASSIGNEE").

WHEREAS, ASSIGNOR adopted, used and is the owner of the trademark BUGATTI for leather goods, including but not limited to the goods identified on the annexed Exhibit A and U.S. Trademark Registration Application Ser. No. 76/536905, filed July 25, 2003, therefore; and

WHEREAS, ASSIGNOR adopted and used a variety of design marks including the word BUGATTI for leather goods, some of which are set forth on the annexed Exhibit B (the word mark BUGATTI and the design marks set forth on Exhibit B shall hereafter be referred to as "the Bugatti Marks");

WHEREAS, ASSIGNEE wishes to acquire all right, title and interest in and to the Bugatti Marks, together with the goodwill of the business symbolized by and associated therewith and any and all applications for registration or registrations therefore; and

WHEREAS, ASSIGNOR is willing to transfer the Bugatti Marks and accompanying goodwill to ASSIGNEE on the terms and conditions set forth herein and in the Settlement Agreement entered into by the parties simultaneously herewith which terms are to be held confidential; and

WHEREAS, the parties wish to effectuate this transfer in a document suitable for recordation with the U.S. Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, ASSIGNOR does hereby assign, sell and transfer to ASSIGNEE, its successors and assigns, all its right, title and interest in and to the Bugatti Marks, together with the goodwill of the business associated therewith, and any pending trademark applications and/or registrations thereof.
