TERMINATION OF SECURITY AGREEMENT

(TRADEMARKS)

WHEREAS, Black Belt, LLC, a Delaware limited liability company, with an address at 300 N. Continental Blvd., Suite 650, El Segundo, California 90245, successor-in-interest to Black Belt Communications, Inc., a Virginia corporation, (jointly referred to as "Assignor"), owns trademark registrations and applications pending in the United States Patent and Trademark Office (the "Trademarks" attached as Exhibit A);

WHEREAS, Assignor had pledged the Trademarks as security for a credit agreement (the "Security Agreement") to MCG Capital Corporation, a Delaware corporation, as agent for the lenders (herein referred to as "Assignee") and granted to Assignee a security interest in all right, title and interest of Assignor in and to the Trademarks (the "Collateral") to secure the prompt payment, performance and observance of certain obligations of Assignor to Assignee (the "Obligations"); and

WHEREAS, the Obligations have been discharged; and

WHEREAS, Assignee desires to terminate the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignee does hereby terminate the Security Agreement evidenced by a Security Agreement dated October 14, 2003, recorded in the U.S. Patent and Trademark Office on November 21, 2003 at reel 2870, frame 0103, and hereby terminates, cancels and releases any and all security interests in and to the Trademarks.
