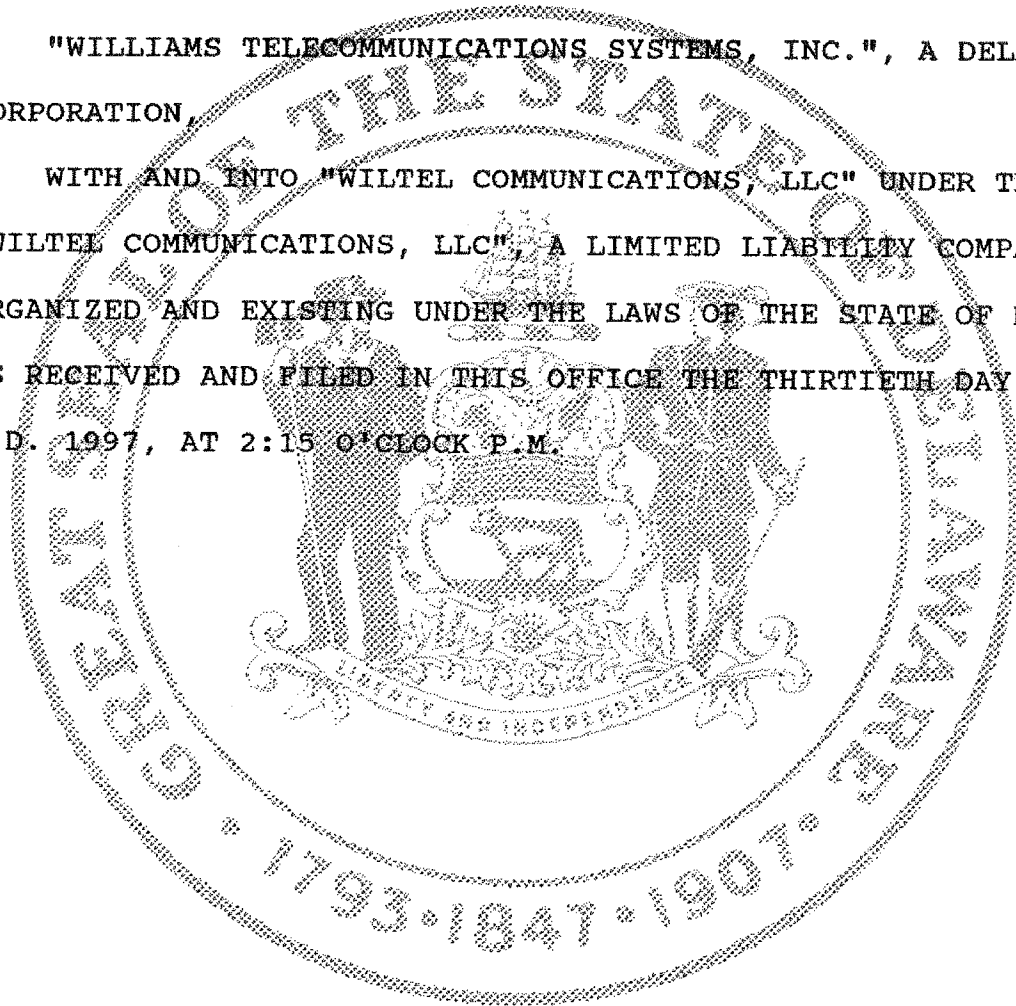

**FIRST:** The name of the jurisdiction of formation or organization and domicile of each of the constituent entities which is to merge are as follows: WiTel Communications, LLC, a Delaware limited liability company, and Williams Telecommunications Systems, Inc., a Delaware corporation.

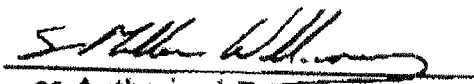
