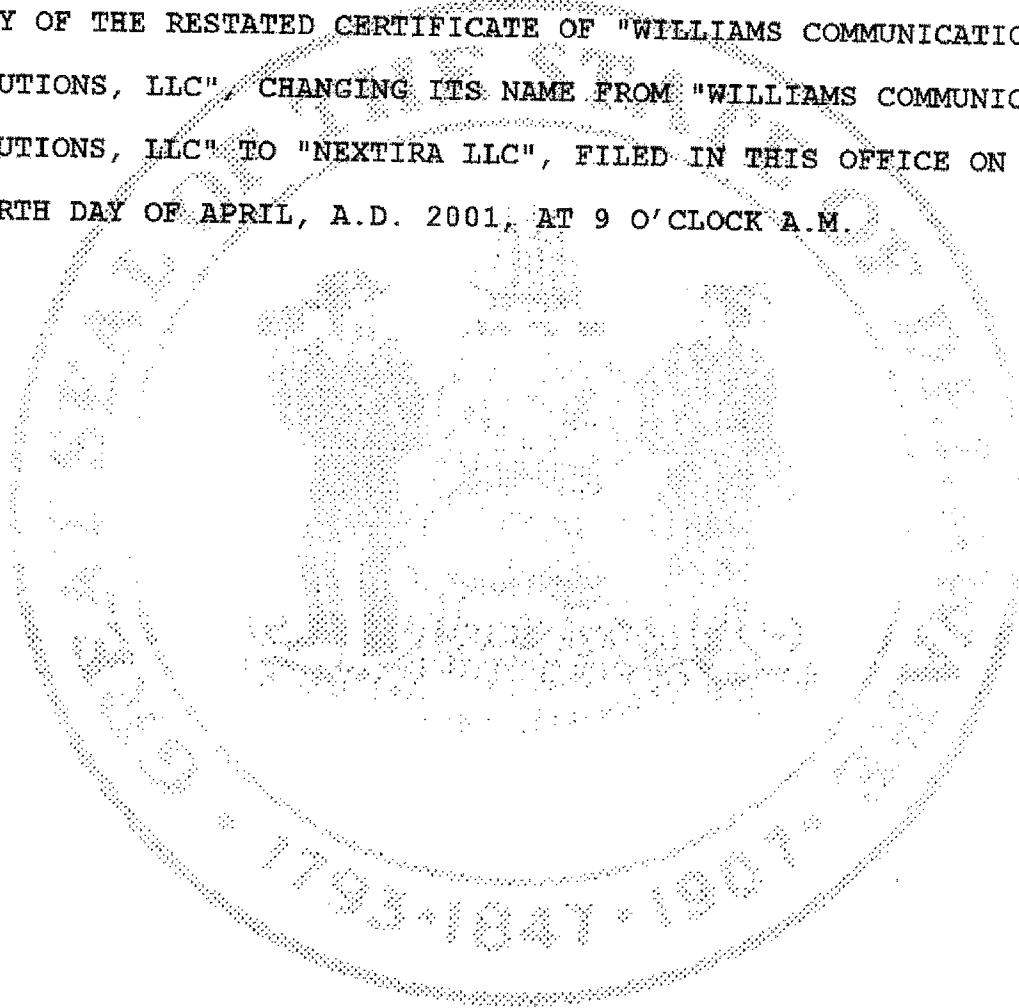

AMENDED AND RESTATED CERTIFICATE OF FORMATION
OF
WILLIAMS COMMUNICATIONS SOLUTIONS, LLC

WILLIAMS COMMUNICATIONS SOLUTIONS, LLC, a Delaware limited liability company (hereinafter called the "Company"), pursuant to Section 18-208 of the Delaware Limited Liability Company Act, DOES HEREBY CERTIFY:

1. The date of filing of the original Certificate of Formation of the Company was April 11, 1997.
2. The original name of the Company was "Wiltel Communications, LLC."
3. A Certificate of Amendment to Certificate of Formation was filed on January 30, 1998, changing the name of the Company to "Williams Communications Solutions, LLC."
4. The Certificate of Formation of the Company is hereby amended and restated to read in its entirety as follows:

FIRST. The name of the limited liability company is Nextira LLC.

SECOND. Its registered office in the State of Delaware is to be located at the Corporation Trust Center, 1209 Orange Street, Wilmington, New Castle County, Delaware 19801, and its registered agent at such address is The Corporation Trust Company.
