**ASSIGNMENT OF APPLICATION**



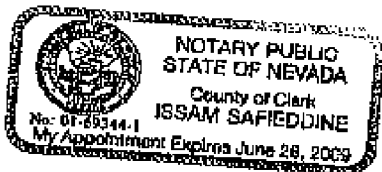
