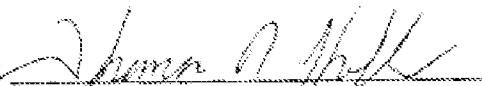
1. That Article FIRST, setting forth the name of the Corporation be, and hereby is, deleted and restated in its entirety as follows:
