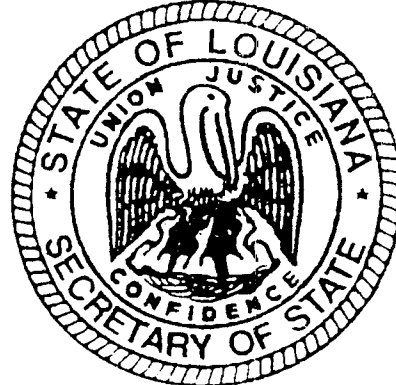




- 1. Article I of the Restated Articles of Incorporation of this Corporation is further amended to read as follows:

- 3. The amendment was adopted by the Corporation’s Sole Stockholder acting by unanimous written consent on July 3, 2001.




