29 This Release of Lien on Trademarks (the "Release"), dated as of March 29, 2006, is made by JPMorgan Chase Bank, N.A. (formerly known as JPMorgan Chase Bank), as administrative agent under the Guarantee and Collateral Agreement referenced below (in such capacity, the "Administrative Agent"), in favor of Panavision International, L.P., a Delaware Limited Partnership ("Grantor").

WHEREAS, Grantor entered into a Guarantee and Collateral Agreement, dated as of May 7, 2002, and recorded in the United States Patent and Trademark Office as of June 19, 2002, at Reel 2527, Frame 0544, pursuant to which Grantor granted to the Administrative Agent a security interest in and lien on all right, title and interest of the Grantor in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

WHEREAS, Grantor entered into a Guarantee and Collateral Agreement, dated as of January 16, 2004, and recorded in the United States Patent and Trademark Office as of February 12, 2004, at Reel 2792, Frame 0166, pursuant to which Grantor granted to the Administrative Agent a security interest in and lien on all right, title and interest of the Grantor in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Obligations have now been satisfied, Grantor has requested that the Administrative Agent release any and all interest it may have in the Released Trademarks, and the Administrative Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date hereinabove set forth.
