Articles of Amendment

Corporations Section

Pursuant to Article 4.04, Texas Business Corporation Act

ARTICLE 1 OLD NAME

The name of the corporation prior to these Articles of Amendment was:

CTI Limited, Inc.

The filing number issued to the corporation by the secretary of state is 0067173200.

ARTICLE 2 NEW NAME

The amendment changes the articles of incorporation to change the article that names the corporation. The article in the Articles of Incorporation is amended to read as follows:

ARTICLE I
