TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is entered into as of the 23rd day of March, 2006, (the "Effective Date") by and between ARMSTRONG WOOD PRODUCTS, INC., a Delaware corporation ("Assignor"), and ARMSTRONG HARDWOOD FLOORING COMPANY, a Tennessee corporation ("Assignee").

WITNESSETH:

WHEREAS, Assignor is the record owner of the trademarks listed in Exhibit A hereto (the "Trademarks"); and

WHEREAS, Assignor desires to assign, transfer and convey to Assignee all right, title and interest in and to the Trademarks, together with all the goodwill of the business, and all common law rights, associated with the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor hereby assigns, transfers and conveys to Assignee all worldwide right, title and interest in and to the Trademarks, together with (i) the goodwill of the business symbolized by the Trademarks, (ii) any and all common law rights, title and interest associated with the Trademarks, and (iii) all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of the Trademarks.
2. Assignor represents and warrants to Assignee that: (i) the Trademarks and use thereof does not and will not violate any trademark or other intellectual property rights of any third party; (ii) Assignor has not previously transferred, assigned, licensed, or otherwise encumbered the Trademarks; and (iii) Assignor will not take any action to interfere with Assignee's worldwide right, title and interest in and to the Trademarks, the goodwill of the business associated therewith, and the common law rights therein and thereto.
3. Assignor further represents and warrants to Assignee that, upon the execution and delivery of this Assignment, Assignee will be vested with all worldwide right, title and interest in and to the Trademarks, free and clear of all liens, claims, licenses or other encumbrances.
4. Assignor further agrees, without further consideration, to cause to be performed such other lawful acts and to be executed such confirmatory assignments and other legal documents as Assignee, or its counsel, may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of each of the rights hereby conveyed.


