**NOTICE OF TERMINATION OF SECURITY INTEREST IN PLEDGED  
TRADEMARKS**

This Notice of Termination of Security Interest in Pledged Trademarks, dated as of March 21, 2006, is executed by Citizens Bank of Massachusetts, as secured party, having a place of business at 28 State Street, Boston, Massachusetts, 02109 (the "Secured Party"), for the purpose of releasing the security interest of the Secured Party in the Pledged Trademarks (as defined below) owned by Escher Group, Ltd., a Massachusetts corporation having a place of business at 101 Main Street, Cambridge, Massachusetts 02142 ("Escher").

*Recitals*

WHEREAS, the Secured Party was granted by Escher, a security interest in the trademarks of Escher, listed on Schedule A hereto (collectively, "Pledged Trademarks") pursuant to that certain Trademark Collateral Security and Pledge Agreement dated as of January 4, 2000 ("Trademark Collateral Security and Pledge Agreement") and recorded in the United States Patent and Trademark Office on January 10, 2000 at Reel 002021, Frame 0114 and July 11, 2003 at Reel 002682, Frame 0414;

WHEREAS, Secured Party has agreed to terminate its security interest in the Pledged Trademarks as partial consideration for Escher's payment to Secured Party of the Payoff Amount (as defined in the Payoff Letter dated as of even date hereof by and between Escher, Secured Party and CapitalSource Finance LLC as agent for certain financial institutions); and

WHEREAS, Secured Party wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the termination of the security interests in and to the Pledged Trademarks previously granted by Escher to Secured Party under and pursuant to the Trademark Collateral Security and Pledge Agreement.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby agrees as follows:

The Secured Party hereby terminates the Secured Party's security interest in the Pledged Trademarks as set forth at the Reel and Frame numbers referenced above.
