Dear Richard,

As you know, Beverly National Bank ("Beverly") and Ciao Foods, Inc. ("Ciao Foods") entered into a [Security Agreement] on June 8, 2000 pursuant to which Ciao Foods granted a security interest to Beverly in the Collateral (as defined therein). Beverly filed two financing statements with the Massachusetts Secretary of the Commonwealth to perfect the security interests granted, the first on June 9, 2000, No. 722526 (the "First Filing"), and the second on February 21, 2001, No. 200100056820 (the "Second Filing").

You have asked us to release the security interest in the collateral with respect to your rights in the trademark "BELLACCINO" and we have agreed. Accordingly, for good and valuable consideration, Beverly hereby releases that portion of the Collateral consisting of Ciao Foods' right, title and interest in and to the trademark "BELLACCINO" (the "Trademark") registered with the U.S. Patent and Trademark Office under Registration No. 2,369,199 which issued July 18, 2000 (the "Registration"), the goodwill in connection therewith, all claims for damages by reason of past infringement of the Trademark or the Registration, and the right to sue for and collect such damages. In furtherance of this release, we authorize Ciao Foods, and its successors and assigns, to file the UCC-3 partial releases with respect to the First Filing and the Second Filing attached hereto.
