RELEASE OF COLLATERAL ASSIGNMENT OF SECURITY  
INTEREST IN TRADEMARKS AND LICENSES

This RELEASE is made by NATIONAL CITY BANK, a national banking association, 1900 East Ninth Street, Cleveland, Ohio 44114 (hereinafter "NCB").

For good and valuable consideration, the receipt and sufficiency of which is acknowledged, NCB hereby releases all rights as an assignee and secured party in and to the Trademarks and Goodwill and the Licenses under the Assignment and reconveys to Marlite any and all rights in the Trademarks and Goodwill and Licenses. NCB further authorizes and requests that the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments, to note in the record, the termination and release of the security interest heretofore granted by Marlite to NCB with respect to the Trademarks and the Goodwill associated therewith and the Licenses.
