Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is Bertek Pharmaceuticals Inc.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the sole shareholder of the corporation on June 18, 2004. The amendment changes Article One of the Articles of Incorporation of the corporation, as amended, and the full text of the provision altered is as follows:

"ARTICLE ONE

The name of the corporation is 'Mylan Bertek Pharmaceuticals Inc.'"

ARTICLE THREE
