ASSIGNMENT AGREEMENT

This Assignment Agreement (the "Assignment") is executed as of April 6, 2006, between LaSalle Bank National Association, a national banking association ("Assignee"), and LaSalle Business Credit, LLC, a Delaware limited liability company ("Assignor").

WITNESSETH:

WHEREAS, Assignor is party to a Loan and Security Agreement dated as of February 13, 2004 (as amended, modified or supplemented from time to time, the "Loan Agreement") by and among LaSalle Business Credit, LLC ("Lender"), DoAll Company ("DoAll"), Contour Saws, Inc. ("Contour"), Continental Machines, Inc. ("Continental") and Greenlee Diamond Tool Company ("Greenlee," and together with DoAll, Contour and Continental, the "Borrowers").

WHEREAS, Assignor has agreed to assign to Assignee all of Assignor's rights and obligations with respect to the loans and other financial accommodations to Borrowers pursuant to the Loan Agreement, and Assignee has agreed to accept such assignment;

NOW, THEREFORE, in consideration of the mutual agreements herein contained, the parties hereto agree as follows:

1. Defined Terms

Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Loan Agreement.

2. Assignment and Assumption

Subject to and in accordance with the terms of the Loan Agreement, Assignor hereby assigns to Assignee, without recourse, representation or warranty (other than as expressly provided herein), and Assignee hereby assumes, all of Assignor's right, title and interest in and obligations arising under the Loan Agreement and the Other Agreements with respect to all of the outstanding Loans to Borrowers and the Letter of Credit Obligations.

3. Payments on Assignment Effective Date


In consideration of the assignment by Assignor to Assignee pursuant to this Assignment, Assignee agrees to pay to Assignor on or prior to the Assignment Effective Date an amount specified by Assignor in writing as the outstanding principal balance of the Liabilities under the Loan Agreement on or prior to the Assignment Effective Date.

4. Effectiveness


This Assignment shall become effective upon the full execution and delivery of this Assignment to the parties to this agreement (the "Assignment Effective Date").
