TRADEMARK ASSIGNMENT

WHEREAS, Michael S. Polsky, as the Court appointed receiver of PRESSED STEEL TANK CO., INC., a corporation duly incorporated and existing under the laws of the State of Delaware, having a principal place of business at 1445 South 66th Street, West Allis, Wisconsin 53214 (“Assignor”), is the owner of the entire right, title and interest in and to the United States trademark registration identified on the attached Schedule A, and all related common law rights, including the goodwill associated therewith (hereinafter the “Trademark”); and

WHEREAS, PST CYLINDERS, LLC, a limited liability company duly organized and existing under the laws of the State of Wisconsin (“Assignee”), desires to acquire Assignor’s entire right, title and interest in and to the Trademark worldwide, together with the goodwill of the business symbolized thereby;

NOW THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that in consideration of the payment of Assignee to Assignor of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby sells, assigns, and transfers unto Assignee all right, title, and interest in and to the Trademark and any applications or registrations therefor, together with all common law rights therein, the goodwill of the business in connection with which the Trademark has been used and which is symbolized by the Trademark, throughout the world, all renewals thereof, and all rights of action, powers, and benefits accrued thereto, including the right to sue for and collect damages and profits for past and future infringements thereof.

Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale. Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform any other acts reasonably deemed necessary by Assignee in order to vest all right, title, and interest in and to the Trademark to Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in the possession or control of Assignor.


