RELEASE OF SECURITY INTEREST

This Release of security interest (hereinafter referred to as "Release") is effective as of the 29th day of March, 2006, by and between FCC, LLC, a Florida limited liability company having a place of business at 1177 Avenue of the Americas, New York, New York, 10036 (hereinafter referred to as "FCC"), and Hartz & Company, Inc. (also known as Hartz & Co., Inc.) a Maryland corporation having a place of business at 1341 Hughes Ford Road, Frederick, Maryland 21701, (hereinafter referred to as "Hartz").

Upon receipt of the purchase price relating to such Trademarks and an executed copy of the sale agreement relating to the sale of such Trademarks, FCC will file such UCC Financing Statement Amendments and US Patent and Trademark Office filings as are necessary for the purpose of evidencing and effectuating the release by FCC of any and all security interests in the Trademarks.


