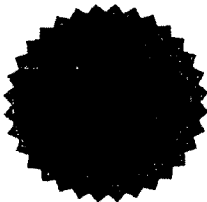


- (1) The name and state of incorporation of each of the constituent corporations is:
