TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made and entered into as of April 12, 2006, by and between FNIS Intellectual Property Holdings, Inc., a Delaware corporation (the "Assignor"), and Fidelity National Tax Service, Inc., a California corporation (the "Assignee").

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is agreed by the parties hereto as follows:



Assignor hereby assigns, sells and sets over to Assignee, all right, title and interest in and to the Mark and Registration therefor, together with the goodwill of Assignor's business symbolized by the Mark and Registration, and all other rights that Assignor has enjoyed thereunder as trademarks, service marks, trade names and otherwise, including, without limitation, all rights and remedies based upon past infringement of the Mark and/or Registration (including the right to sue and collect damages and profits for such infringement).

2. Assignor covenants and agrees that it will, at any time, on request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the aforementioned assets and rights assigned by this Assignment.
