DECLARATION OF STEPHANIE B. TILLMAN

1. My name is Stephanie B. Tillman. I am Vice President and Associate General Counsel of Flowers Foods, Inc. The information set forth in this declaration is based on my personal knowledge and on documents maintained under my supervision by employees of Flowers Foods, Inc.

2. On February 1, 2006, Derst Baking Co., the original owner of Registration Nos. 1,983,952 of the mark GOT YA BAR, 1,983,953 of the mark NANA NUT, 2,119,602 of the mark CAPTAIN JOHN DERST'S GOOD OLD FASHIONED BREAD, and 2,173,031 of the mark CAPTAIN JOHN DERST'S, was merged into Derst Acquisition Co., LLC, a subsidiary of Flowers Foods, Inc. As a result of this merger, ownership of Registration Nos. 1,983,952, 1,983,953, 2,119,602, and 2,173,031, of the marks underlying them, and of the marks' associated goodwill became vested in Derst Acquisition Co., LLC.
