

**RELEASE AND REASSIGNMENT OF TRADEMARKS**

THIS RELEASE AND REASSIGNMENT dated March 31, 2006 by Harris N.A., as Agent as hereinafter described:

**WITNESSETH:**

WHEREAS, HARRIS N.A., as successor by merger with Harris Trust and Savings Bank, a national banking association with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (the "*Agent*") and AARON INDUSTRIES, INC., a Delaware corporation with its mailing address at 1784 Highway 72 West, Clinton, South Carolina 29325 (the "*Debtor*") are parties to a certain Trademark Collateral Agreement dated March 31, 2004 which was recorded in the United States Patent and Trademark Office on April 19, 2004 at Reel 002950, Frame 0472 (the "*Assignment*"), pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A-1 and Schedule A-2 attached hereto and certain other property (collectively, the "*Trademarks*"); and

- (ii) Each trademark license listed on Schedule A-2 hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and
- (iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages.
