

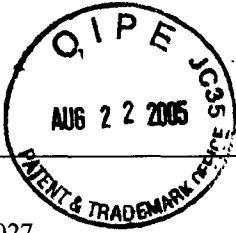

RELEASE OF SECURITY INTEREST IN TRADEMARKS

15 THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of August 15, 2005 (this "Release"), is made by Comerica Bank, N.A. (the "Lender"), with respect to that certain Amended and Restated Loan and Security Agreement dated as of May 6, 2004, and that certain Amended and Restated Intellectual Property Security Agreement entered into as of May 6, 2004, the latter having been recorded in the records of the United States Patent and Trademark Office at Trademark Reel 3044, Frame 0219 (collectively, the "Security Agreements"), between Alex eSolutions, Inc. (the "Grantor"), and the Lender.

WITNESSETH:


