## TERMINATION AGREEMENT

This Termination Agreement dated as of the 31st day of March, 2006 is between PRAIRIE PACKAGING, INC., a Delaware corporation (“**Prairie**”) and LASALLE BANK NATIONAL ASSOCIATION, a national banking association, as agent (the “**Collateral Agent**”) for the Banks and the Noteholders (as defined in the Credit Agreement). For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Prairie and the Collateral Agent agree as follows:

### RECITALS:

A. Prairie and the Collateral Agent are parties to a Trademark Security Agreement dated as of September 24, 2004 (the “**2004 Trademark Agreement**”) whereby Prairie, among other things, granted the Collateral Agent a security interest in certain trademarks, registrations of trademarks and other intangibles as security for certain loans and other extensions of credits;

B. Prairie and the Collateral Agent are parties to a Trademark Security Agreement dated as of August 31, 1994 (the “**1994 Trademark Agreement**”) whereby Prairie, among other things, granted the Collateral Agent a security interest in certain trademarks, registrations of trademarks and other intangibles as security for certain loans and other extensions of credits;

C. Prairie and the Collateral Agent wishes to terminate the 2004 Trademark Agreement and the 1994 Trademark Agreement and the security interests granted thereunder.

### AGREEMENT:

1. Definitions. All terms which are used but not otherwise defined herein shall have the meanings ascribed to them in the 2004 Trademark Agreement or 1994 Trademark Agreement, as applicable.

2. Termination of Agreement. Prairie and the Collateral Agent hereby terminate the 2004 Trademark Agreement and agree that hereafter neither of them nor any other person shall have any rights or obligations thereunder. Furthermore, Prairie and the Collateral Agent hereby terminate the 1994 Trademark Agreement and agree that hereafter neither of them nor any other person shall have any rights or obligations thereunder.

3. Termination of Security Interest. The Collateral Agent hereby terminates and releases the security interests granted to it under the provisions of the 2004 Trademark Agreement and the 1994 Trademark Agreement and assigns and transfers to Prairie all of its rights, titles and interests, if any, in the United States and throughout the world, in and to the Trademarks (as defined in the 2004 Trademark Agreement or the 1994 Trademark Agreement), including without limitation (a) all of Prairie’s currently

owned or hereafter acquired trademarks, registrations of trademarks and use-based applications for trademark registration pending before the United States Patent and Trademark Office, together with the goodwill of the business symbolized by such trademarks, including, without limitation, those United States trademark applications for trademark registrations listed on Schedule A and Schedule B attached hereto and made a part hereof, (b) all of Prairie's currently owned or hereafter acquired trademarks, registration of trademarks and use-based applications for trademark registration pending before the trademark offices of foreign countries, (c) all income, royalties, damages and payments now and hereafter due and/or payable under or based on such trademarks, and (d) all rights to sue, collect and retain damages and payments for past and future infringements and violation of the rights thereof.

4. Governing Law. This Termination Agreement shall be a contract made under and governed by the laws of the State of Illinois, without regard to conflict of laws principles.

IN WITNESS WHEREOF, the Collateral Agent and Prairie have executed this Termination Agreement as of the day and year first above written.


