TRADEMARK ASSIGNMENT AGREEMENT

- Parties; Effective Date.** This Trademark Assignment Agreement ("Agreement") is entered into between Ghostly International LLC, a Michigan limited liability company ("Assignor") and V4 Holdings, LLC, a Michigan limited liability company ("Assignee"). This Agreement is effective as of April 5, 2006
- Purpose of Agreement.** Assignor is the owner of the trademarks "GHOSTLY," U.S. Trademark Registration No. 2,811,089, and MISCELLANEOUS DESIGN, U.S. Trademark Registration No. 2,843,445 (the "Marks"), and seeks to assign to Assignee, and Assignee seeks to acquire, the Marks pursuant to this Agreement.
- Assignment of Marks.** For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, sells, transfers and conveys all right, title and interest in and to the Marks, including, without limitation: (a) all goodwill associated with the Marks, and all goodwill associated with the goods to which the Marks pertain; (b) the U.S. Trademark Registrations for the Marks, and any renewals thereof; and (c) any and all other rights, whether statutory or common law, corresponding thereto and all other rights of any kind whatsoever accruing thereunder, together in each case with the goodwill of the business connected with the use of, and symbolized by the Marks.
- Binding Effect.** This Agreement shall be binding upon and inure to the benefit of the parties' heirs, representatives, successors, and assigns.
