TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is WINDMERE CORPORATION (the "Corporation"), Charter #P96000028274

2. The following Amendment to the Articles of Incorporation was adopted by the unanimous written consent of the Directors and the Sole Shareholder of the Corporation, the number of votes cast being sufficient for approval, as of May 9, 2000 in the manner prescribed by Section 607.1003 of the Act.

3. Article I of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article I, as follows:

"ARTICLE I

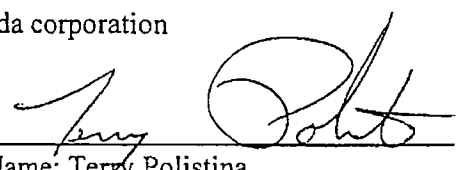
The name of the corporation is APPLICA CONSUMER PRODUCTS,

4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.

5. The effective date of this amendment shall be upon the filing of these Articles of Amendment.
