TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into effective as of this 17th day of April, 2006 by and between True Value Company, f/k/a TrueServ Corporation, a Delaware corporation ("Assignor"), and CenterPoint Energy Field Services, Inc., f/k/a Reliant Energy Field Services, Inc., a Delaware corporation ("Assignee").

Assignor agrees that it shall, without additional compensation, execute and deliver further instruments of conveyance, transfer and assignment as requested by Assignee, its successors, or assigns; reasonably cooperate and assist in providing information for making and completing regulatory and other filings; and take any and all other actions as Assignee, its successors, or assigns may reasonably require to effectively assign, convey, transfer, protect,
