DEED OF AMENDMENT TO THE ARTICLES OF ASSOCIATION OF
MARIANA HDD B.V.

On this day, the [thirty-first] day of December two thousand and two appears before me, **, notaris (civil-law notary) practising in Amsterdam:

The person appearing declares that on ** two thousand and two the sole shareholder of Mariana HDD B.V., a private company with limited liability, with corporate seat in Amsterdam and address at: 1066 VH Amsterdam, Johan Huizingalaan 765, resolved to amend the articles of association of this company and to authorise the person appearing to execute this deed.

Pursuant to those resolutions the person appearing declares that she amends the company's articles of association as follows:

Article 1, first sentence shall be amended as follows:

The name of the private company with limited liability is:
Hitachi Global Storage Technologies Netherlands B.V.

Article 3, paragraph 1 shall be amended as follows:

3.1. The authorised share capital of the company amounts to seventy million eighteen thousand euro (EUR 70,018,000). It is divided into seven thousand (7,000) ordinary shares B of ten thousand euro (EUR 10,000) each, three thousand (3,000) preference shares A of one euro (EUR 1) each and fifteen (15) preference shares C, of one thousand euro (EUR 1,000) each.
