THIS ASSIGNMENT is entered between CLINICAL DATA, INC. and DADE BEHRING INC. effective as of the date of signing below.





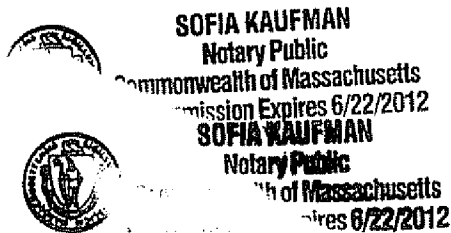
