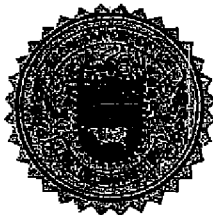

Pursuant to Title 8, Section 252, of the  
Delaware General Corporation Law

The undersigned corporation, organized and existing under and by virtue of the General Corporation Law of Delaware ("DGCL"), hereby certifies that:

**FIRST:** The names of the constituent corporations are REDOX ACQUISITION CORP., a Delaware corporation ("Redox Acquisition"), and REDOX BRANDS, INC., an Ohio corporation ("Redox").

**SECOND:** The surviving corporation will be Redox Acquisition, following the merger of Redox with and into Redox Acquisition (the "Merger").

**THIRD:** As a result of the Merger, the name of the surviving corporation will be changed to REDOX BRANDS, INC.

**FOURTH:** An Agreement and Plan of Merger between the parties to the Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8, Section 252(c), of the DGCL.

**FIFTH:** The Certificate of Incorporation of Redox Acquisition, which will survive the Merger, shall be the Certificate of Incorporation of the surviving corporation and shall be amended to change the name of the surviving corporation to "Redox Brands, Inc."

**SIXTH:** The authorized stock and par value of the non-Delaware corporation is 5,000,000 shares of common stock, without par value, and 3,400,000 shares of Series A Convertible Preferred Stock, without par value.

**SEVENTH:** The Merger shall become effective as of the date of filing this Certificate of Merger with the Secretary of State of the State of Delaware.

**EIGHTH:** The Agreement and Plan of Merger is on file at the principal place of business of the surviving corporation at 9100 Centre Pointe Drive, Suite 200, West Chester, Ohio 45069.

**NINTH:** A copy of the Agreement and Plan of Merger will be furnished by the surviving corporation on request and without cost, to any stockholder of the constituent corporations.
