

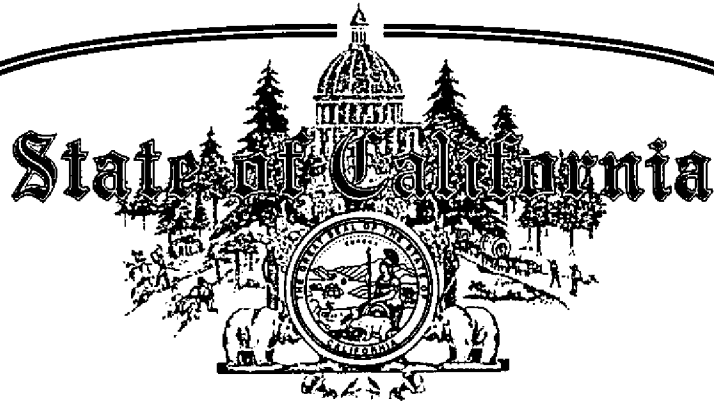

5. This certificate shall become effective on January 1, 2005 at 12:01 a.m. Eastern time.


