**CERTIFICATE OF MERGER  
OF  
SPRINGER PUBLISHING COMPANY, INC.  
INTO  
NEW SPRINGER LLC**

(Under Section 1003 of the New York Limited Liability Company Law)

Springer Publishing Company, Inc., a New York corporation, and New Springer LLC, a New York limited liability company, pursuant to the provisions of Section 1003 of the Limited Liability Company Law of the State of New York, each hereby certifies as follows:

**FIRST:** The names and jurisdiction of incorporation or organization of each business entity that is to merge is as follows:

A. Springer Publishing Company, Inc., a New York corporation (“Springer Publishing”), and

B. New Springer LLC, a New York limited liability company (“New Springer”).

**SECOND:** A. The Articles of Incorporation of Springer Publishing were filed with the Department of State of the State of New York on December 28, 1950 under the original name Springer Publishing Co., Inc.

B. The Articles of Organization of New Springer were filed with the Department of State of the State of New York on February 28, 2006.

**THIRD:** A. A Plan of Merger and an Agreement of Merger were duly approved and adopted by unanimous written consent of the Board of Directors of Springer Publishing, pursuant to Section 708 of the New York Business Corporation Law.

B. An Agreement of Merger was duly approved and adopted by written consent of the Sole Member of New Springer, pursuant to Section 407 of the New York Limited Liability Company Law.

C. An Agreement of Merger has been executed by each corporation and limited liability company that is a party thereto.

**FOURTH:** New Springer shall be the surviving entity of the merger (the “Surviving Entity”).

**FIFTH:** Pursuant to Section 1003 of the New York Limited Liability Company Law, the Articles of Organization of New Springer is hereby amended to change the name of the limited liability company to “Springer Publishing Company, LLC.”

**SIXTH:** The merger of Springer Publishing with and into New Springer shall be effective as of March 31, 2006.

**SEVENTH:** The Secretary of State of the State of New York is designated as agent of the limited liability company upon whom process against it may be served. The post office address within or without this State to which the Secretary of State shall mail a copy of any process against the limited liability company served upon him or her is 11 West 42<sup>nd</sup> Street, 15<sup>th</sup> Floor, New York, NY 10036.


**EIGHTH:** The Agreement of Merger is on file at the place of business of the Surviving Entity. Such place of business is located in New York County and its address is 11 West 42<sup>nd</sup> Street, 15<sup>th</sup> Floor, New York, NY 10036.

**NINTH:** A copy of the Agreement of Merger will be furnished by the Surviving Entity on request and without cost to any member of the Surviving Entity or to any person holding interest in any other business entity that is to merge pursuant to such agreement.


