**RELEASE OF SECURITY INTEREST (PATENTS AND TRADEMARKS)**

THIS RELEASE OF SECURITY INTEREST (the "Release") is made as of this \_\_\_\_\_ day of April, 2005, by Madeleine L.L.C., a New York limited liability company, as collateral agent for certain lenders (in such capacity, "Madeleine") pursuant to that certain Financing Agreement dated as of June 10, 2003, as amended from time to time (the "Financing Agreement") in favor of Fila Luxembourg S.a.r.l. ("Debtor").

WHEREAS, pursuant to the Financing Agreement, Debtor executed and delivered certain Patent Security Agreements and Trademark Security Agreements, each dated June 10, 2003 (collectively, the "Security Agreements") in favor of Madeleine;

WHEREAS, the Security Agreements were recorded at the United States Patent and Trademark Office on June 13, 2003 as set forth on Exhibit A; and

WHEREAS, pursuant to the Security Agreements, Debtor granted to Madeleine a continuing security interest in its right, title and interest in and to the patents and patent applications, the trademark registrations and trademark applications identified on Exhibit B attached hereto and made a part hereof (collectively, the "Secured Collateral");

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which is hereby acknowledged, Madeleine, in its capacity as collateral agent for the Lenders (as defined in the Financing Agreement), hereby unconditionally and expressly releases and terminates, without representation or warranty of any kind or nature, its security interest in and to the Secured Collateral, and Madeleine hereby assigns, without representation or warranty of any kind or nature, any such right, title and interest it may have in the Secured Collateral (if any) to Debtor. Madeleine further agrees to execute and deliver to Debtor any and all further documents or instruments and do any and all further acts which Debtor reasonably requests in order to confirm this Release, in each case at the expense of Debtor.

This Release shall be binding upon Madeleine's legal representatives, assigns and successors.
