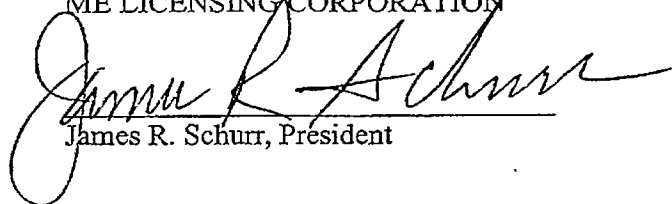
Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

- SECOND: The Articles of Incorporation of the Corporation are amended by changing the Article 1 so that, as amended, said Article shall read as follows:
