Coburn, President of Assignee, have entered into that certain Asset Purchase Agreement dated October 26, 2005, ("the Agreement") wherein Assignor agreed to sell, transfer, and assign to Mr. Coburn certain assets of Assignor, including, but not limited to, the OTTERWEAR trademark.

WHEREAS, Mr. Coburn has authorized the transfer of the OTTERWEAR trademark to Assignee as his designee.

WHEREAS, Assignor and Mr. Coburn agree that the Agreement runs to the benefit of Assignee as Mr. Coburn's designee.

WHEREAS, Assignor and Mr. Coburn agree that following the execution of this Assignment transferring the OTTERWEAR trademark to Assignee as Mr. Coburn's designee, Assignor shall have complied with its obligations under the Agreement regarding the transfer of the OTTERWEAR trademark;

NOW THEREFORE, Assignor, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, **DOES HEREBY** irrevocably and unconditionally assign and transfer to Assignee as Mr. Coburn's designee all of Assignor's right, title and interest in free and clear of all liens, security interests and other encumbrances, in and to the OTTERWEAR trade name, trademark and trademark applications and/or registrations, including without limitation U.S. Registration No. 2,873,582, together with the goodwill of the business symbolized by said trade name, trademark and trademark applications and/or registrations, including any and all past and present rights and powers, statutory and common law, which have accrued or may accrue to Assignor of any and all kind or nature appertaining to said trade name, trademark and trademark applications and/or registrations the same to be held and enjoyed by Assignee and for the use and benefit of its successors and assigns as fully and entirely as the same would have been held by Assignor had such sale, assignment and transfer not have been made, (the "Trademark"),

TO HAVE AND TO HOLD the Trademark, with all of the rights and appurtenances thereto belonging unto Assignee, for itself, its successors and assigns for their own use and behalf forever.

For good and valuable consideration, the sufficiency of which is hereby acknowledged, Assignor covenants that Assignor will do, execute and deliver, or will cause to be done, executed and delivered, all such further reasonable acts, transfers, assignments and conveyances, powers of attorney and assurances, for the better assuring, conveying and confirming unto Assignee, the entire right, title and interest in the Trademark hereby sold, transferred, assigned, and conveyed as Assignee may reasonably require.

This Assignment and covenants and agreements herein contained shall inure to the benefit of Assignee, its successors and assigns, and shall be binding upon Assignor, his successors and assigns.

This Assignment shall be governed by and construed in accordance with the internal laws of the State of Missouri.
