**CONFIRMATORY ASSIGNMENT

WHEREAS, ASSIGNOR desires to confirm and record with the United States Patent and Trademark Office the December 31, 2005 assignment of said TRADEMARKS to ASSIGNEE;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby acknowledges and confirms that, effective December 31, 2005, ASSIGNOR sold, transferred, and assigned to ASSIGNEE the entire right, title, and interest in and to the TRADEMARKS, together with the goodwill of the business appurtenant thereto and symbolized by said TRADEMARKS, and all rights of action against third parties for past infringement thereof, the same to be

held and enjoyed by said ASSIGNEE as fully and entirely as the same would have been held by ASSIGNOR had this sale, transfer, and assignment not been made.

ASSIGNOR hereby warrants and covenants that it had the full power and authority to convey the right, title, and interest sold, transferred, and assigned to ASSIGNEE on December 31, 2005, that it has not executed and will not execute any agreement in conflict therewith, and that it will execute any and all other instruments that may be necessary to evidence ASSIGNEE's ownership of the TRADEMARKS and all rights conveyed in the December 31, 2005 assignment.
