RELEASE OF SECURITY INTEREST

This Release of Security Interest, effective as of April 18, 2006 (the "Effective Date"), is made by NATIONAL CITY BANK, as "Agent" for the "Secured Parties" (as defined in the "Security Agreement", as defined herein) with a principal place of business at One South Broad Street, 14th Floor, Philadelphia, Pennsylvania 19107 (the "Agent"), in favor of MARQUIS WHO'S WHO LLC, a Delaware limited liability company, with a principal place of business at 603 Central Avenue, New Providence, New Jersey 07974 (the "Debtor").

WHEREAS, on June 15, 2004, Debtor and Agent entered into a certain Security Agreement (the "Security Agreement") which provided for the grant by Debtor to Agent of a security interest in the trademarks described on the attached Schedule A, (the "Trademarks") owned by Debtor; and

WHEREAS, on August 18, 2004, Agent recorded in the Patent and Trademark Office, U.S. Department of Commerce at Reel/Frame 2928/0870, the Security Agreement, evidence of its security in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, as of the Effective Date, Agent hereby (1) releases, discharges and relinquishes its security interest in and lien on all of the Trademarks, as listed on Schedule A, and (2) reassigns to Debtor all right, title, and interest that Agent may have had in and to the Trademarks, including all goodwill of the business associated with the Trademarks, and the applications for and registrations thereof, and all renewals and extensions thereof, and any and all causes of action for infringement thereof, and any and all royalties for any licenses thereof. Agent specifically acknowledges that the Security Agreement is no longer effective as to the Trademarks, and that Agent does not own any rights to or have any ownership interest or claim in any of the Trademarks.

Agent acknowledges and confirms that the terms and conditions of this Release of Security Interest shall be effective evidence of the release of the security interests in the Trademarks.


