**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** is made as of April 12, 2006, by **WINDWARD CAPITAL MANAGEMENT, LLC** (the "**Grantee**").

WITNESSETH:

**WHEREAS**, Grantee and Festival Fun Parks, LLC, a Delaware limited liability company ("**Grantor**"), are parties to that certain Trademark Security Agreement dated as of March 5, 2004 (the "**Security Agreement**"; Capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Security Agreement), pursuant to which Grantor granted a security interest to Grantee in certain Trademark Collateral as security for certain obligations owing by Grantor to Grantee, including the Trademarks set forth on Schedule 1 hereto; and

**WHEREAS**, Grantor has requested that Grantee release its security interest in the Trademark Collateral and reassign the same to Grantor.

**NOW THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "**Trademark Collateral**"):
  - (a) all trademarks, trade names, corporate names, company names, business names, fictitious business names, service marks, logos, other business identifiers, all registrations (together with any reissues, continuations or extensions thereof), and all applications therefor and renewals thereof (all of the foregoing in this clause (1) and any part thereof are referred to herein as the "**Trademark**"), including, without limitation, the Trademarks listed on Schedule 1 annexed hereto;
  - (b) all Trademark licenses, including, without limitation, the material Trademark licenses listed on Schedule 1 annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such license of a Trademark; and
  - (c) all products, proceeds, income, royalties, damages and payments now or hereafter due and/or payable under or with respect to any of the foregoing, including, without limitation, damages and payments for past, present and future infringements of any of the foregoing and the right to sue for past, present and future infringements of any of the foregoing.

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest in and to the Trademark Collateral.
