Assignor further consents to the recordation of this Assignment by Assignee with the United States Commissioner of Patents and Trademarks or any similar foreign government agency.

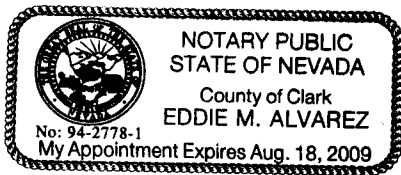
