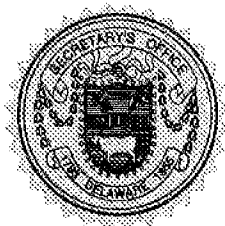

Night Vision Equipment Co., Inc.

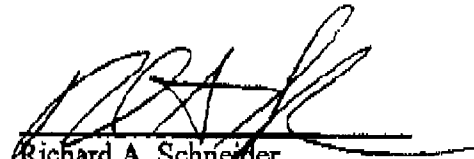
