
Dear Sir:

On August 3, 2004, at Reel 2907/Frame 0773, a merger document was recorded regarding Registration No. 2,311,177 indicating that the purported owner of the registration, Dynacraft LLC, was merging into Dynacraft BSC, Inc. However, the true owner of Registration No. 2,311,177 is now, and was at the time this merger document was recorded, **RAZOR USA LLC**, as reflected in the assignment recorded at Reel 2187/Frame 0913 on November 16, 2000. Accordingly, the entity that filed the aforementioned merger document, not being the true owner, had no authority to file such a document. Counsel for this entity has been contacted about correcting the record, but is unwilling or unable to file a corrective document.

Moreover, on August 16, 2004, at Reel 3025/Frame 0011, a security agreement was recorded against Registration No. 2,311,177, purporting to convey a security interest from Dynacraft Industries, Inc. to The Cit Group/Commercial Services, Inc. However, as indicated above, RAZOR USA LLC was the true owner of the registration at the time this security interest was recorded and, as such, Dynacraft Industries, Inc. had no authority to convey a security interest in the registration. Counsel for this entity has been contacted about correcting the record, but is unwilling or unable to file a corrective document.

Accordingly, the chain of title for the registration should not be considered altered by the improperly recorded merger document and security interest because the true owner of the registration, RAZOR USA LLC, was the owner of the registration at the time these documents were improperly recorded.

The undersigned being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or document or any registration resulting therefrom, declares that all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.
