

ASSIGNMENT OF TRADEMARK

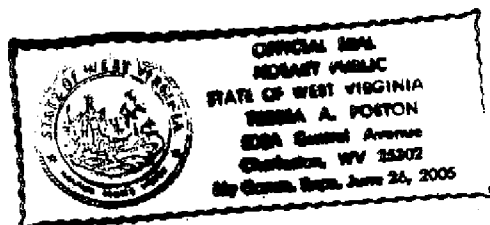
