SECURITY INTEREST IN TRADEMARKS


Reference is made to that certain Intellectual Property Security Agreement dated as of April 11, 2000, by and among Central Lewmar, L.P., McCarter Paper Company, Inc., McClellan Street Urban Renewal Associates, L.L.C., Berkowitz Company, L.P., McClellan Paper Company, Inc. and Strategic Paper Group, L.L.C. (collectively, the "Grantor") and General Electric Capital Corporation, as Agent (the "Agent") and recorded at the United States Patent and Trademark Office at Reel 002088 and Frame 0235 on May 3, 2000 (the "Security Agreement").
