TERMINATION AND RELEASE OF SECURITY INTERESTS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS (the "Release") is made as of the 20th day of April, 2006 (the "Execution Date") by Glenfed Financial Corporation, a dissolved California corporation ("Releaser"), in favor of Hollinee, LLC, a Delaware limited liability company, as successor to Hollinee Corporation, a Delaware corporation, as successor to Hollihold, Inc., a Pennsylvania corporation ("Releasee").

RECITAL

Pursuant to a Security Agreement dated June 30, 1986 (the "Security Agreement"), which was recorded with the United States Patent and Trademark Office on January 29, 1987, Releaser is the grantee of a certain security interest and mortgage in certain trademarks as listed in Appendix A (the "Trademarks"), which was granted to Releaser by Releasee. Releasee has paid and performed in full its obligations to Releaser and terminated all further obligations of Releaser to extend credit to Releasee. Releaser desires by execution of this Release to grant to Releasee a termination and release of all of its security interests in and its rights, title, and interest in and to the Trademarks.

RELEASE

Releaser hereby terminates and releases its security interest in and mortgage on all of the Trademarks, and Releaser further assigns and transfers to Releasee, without recourse, Releaser's entire rights, title, and interest in and to all of the Trademarks, which were pledged in the Security Agreement, effective as of the date set forth above.
