ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF VI VALUATION SERVICES, INC.

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, VI VALUATION SERVICES, INC. (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation.

ARTICLE 1

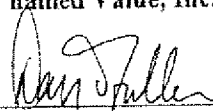
ARTICLE 4
