ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (the "Assignment") is made effective as of March 17, 2006 between Arlie Jean Phillips, Individually and as Trustee of the ARLIE JEAN PHILLIPS REVOCABLE TRUST dated October 29, 2003 ("Assignor") and EAC Partners, LLC, a California limited liability company ("Assignee") with reference to the following:

A. Assignor is the owner of the trademark listed on Schedule A attached hereto and incorporated herein (the "Mark") and the United States and International Registration of the Mark listed on Schedule A (the "Registration"). Assignee desires to acquire and own exclusively the entire right, title and interest in and to the Mark and the Registration (collectively, the "Trademark Rights") for all purposes, and all goodwill relating thereto, whether such rights are based in common law or under federal or state statute.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignment of the Trademark Rights. Assignor hereby sells, assigns, transfers and conveys to Assignee and its successors and assigns full and exclusive right, title and interest in the Trademark Rights that Assignor may now have or ever has had for any and all purposes, together with all goodwill of the business symbolized by the Trademark Rights. The foregoing assignment of the Trademark Rights shall include without limitation: (a) the right to register and renew the registrations of the Mark in the United States and in any foreign country, (b) the exclusive right to sell, assign, lease, license, use or otherwise transfer or exploit the Trademark Rights, and (c) the right to enforce, sue for and collect damages by reason of any past, present or future infringement or misuse of the Trademark Rights, except past acts by Assignor or Yasu Eguchi. This Assignment is absolute, exclusive and irrevocable.


2. Further Assurances. Assignor agrees to execute and deliver to Assignee any and all instruments and documents that may be necessary or convenient, and to provide all assistance reasonably requested by Assignee to evidence, maintain, defend, effect, or enforce this Assignment as well as Assignee's right, title and interest in and to the Trademark Rights and to effect the assignment and transfer of the Registration to Assignee, including but not limited to the recordation of this Assignment in the United States Patent and Trademark Office and in any foreign country or jurisdiction.

3. Governing Law. This Assignment shall be governed by and interpreted pursuant to the laws of the State of California.

4. Counterparts. This Assignment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same document.


