**SUPPLEMENT TO SECURITY AGREEMENT
(TRADEMARKS)**

WHEREAS, BlueStreak Technology Inc., a Texas corporation (herein referred to as "**Grantor**"), having an address at 2323 Bryan Street, Suite 1800, Dallas, Texas 75201, has (1) adopted, used and is using, or (2) intended to use and filed an application indicating that intention, but has not yet filed an allegation of use under Section 1(c) or 1(d) of the Trademark Act, or (3) filed an application based on an intention to use and has since used and has filed an allegation of use under Section 1(c) or 1(d) of Trademark Act, the trademarks, trade names, trade styles and service marks listed on the annexed Schedule 2-A, which trademarks, trade names, trade styles and service marks are registered in the United States Patent and Trademark Office (the "**Trademarks**"); and

WHEREAS, the Grantor has entered into a Security Agreement (said Security Agreement, as it may hereafter be amended, restated, supplemented or otherwise modified from time to time being the "**Security Agreement**", the terms defined therein and not otherwise defined herein being used herein as therein defined), dated as of April 11, 2006, in favor of BDC Capital Inc. and Fonds de Solidarité des Travailleurs du Québec (F.T.Q.) (together, the "**Secured Parties**" and, individually, a "**Secured Party**"); and

WHEREAS, pursuant to the Security Agreement, the Grantor has granted to each Secured Party, its successors and assigns, a security interest in, and mortgage on, and a pledge and assignment of, all right, title and interest of the Grantor in and to the Trademarks, together with all prints and labels on which said Trademarks have appeared or appear, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, and the goodwill of the business symbolized by the Trademarks and the applications, registrations and recordings in the United States Patent and Trademark Office or in any similar office or agency of the United States of America, any State thereof, or any other country or any political subdivision thereof, all whether now or hereafter owned or licensable by Grantor, and all reissues, extensions or renewals thereof, all Trademark Licenses and all proceeds and products of all of the foregoing, including, without limitation, any claims by Grantor against third parties for infringement thereof (the "**Collateral**"), to secure the payment and performance of the Secured Obligations.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantor does hereby further confirm, and put on the public record, its grant to each Secured Party of a security interest in and mortgage on the Collateral to secure the prompt payment and performance of the Secured Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of each Secured Party with respect to the grant of, security interest in and mortgage on the Collateral made hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
