NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:



ASSIGNOR covenants that it has the authority to enter into this agreement.


ASSIGNOR covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into that would conflict with this assignment and sale.




