The undersigned, being the Chief Executive Officer of Phelps Dodge High Performance Conductors of SC & GA, Inc., a New York corporation (the "Corporation"), does hereby certify that:

1. The name of the Corporation is Phelps Dodge High Performance Conductors of SC & GA, Inc. The name under which said corporation was formed was Hudson Wire Company.
