**MEMORANDUM AND NOTICE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

Cadence Innovation LLC, a Delaware limited liability company (formerly known as New Venture Holdings, LLC), whose address is 6555 15 Mile Road, Sterling Heights, MI 48312 (“Grantor”) hereby acknowledges the following:

Grantor and Bank of America, N.A., with an office at 55 South Lake Avenue, Suite 900, Pasadena, California 91101 (as administrative agent for the Lenders, the “Agent”), are party to that certain Amended and Restated Credit Agreement, dated as of October 31, 2005 (as amended, modified, renewed or extended from time to time, the “Credit Agreement”) by and among the Grantor, New Venture Real Estate Holdings, LLC, a Michigan limited liability company (“NVRE Holdings”) the Agent and the financial institutions from time to time party thereto (the “Lenders”); and


Under the terms of the Credit Agreement and that certain Amended and Restated Security Agreement, dated as of October 31, 2005 (as amended, modified, renewed or extended from time to time, the “Security Agreement”), entered into between the Grantor, NVRE Holdings and the Agent, Grantor has granted to the Agent, for the ratable benefit of the Agent and the Lenders, a security interest in: (a) the trademarks and trademark registrations and applications therefor which are identified on Schedule A attached hereto and incorporated herein by this reference (the “Trademarks”), together with the goodwill thereto; and (b) the patents and patent applications which are identified on Schedule B attached hereto and incorporated herein by this reference (the “Patents”), owned by Grantor, which Trademarks and Patents are appurtenant, and all actions for infringement concerning the foregoing.

Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which the Agent may have in any other collateral described in the Security Agreement or otherwise. Capitalized terms used but not defined herein shall have the meanings given them in the Credit Agreement.
